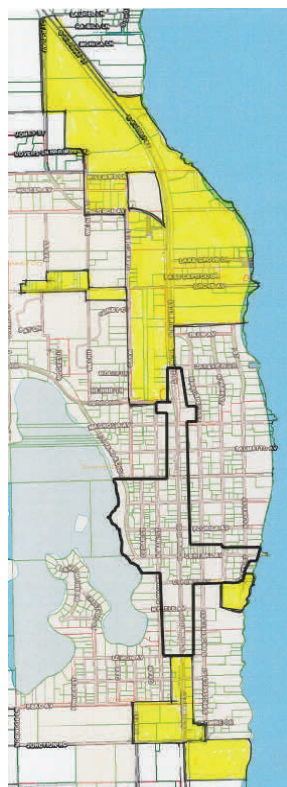

With the help of an FDOT grant, Crescent City will be paving Walnut Street from CR308 to Grove Avenue. The project is out for bid and we expect to award the project at the January Commission meeting, which means we should see construction start in the early spring!

We are optimistic that the paving of Clemmons Lane and the resurfacing of Bay St will follow soon after with the help of a CDBG grant.
