PHFC Expands Group Exercise Programs

The Putnam Health & Fitness Center (PHFC) announces the expansion of the group exercise schedule beginning Tuesday, September 5th, 2017. New classes are being added to both the morning and evening schedules offering more variety and a broader choice of class design to the entire community regardless of age, fitness level or body shape.

The current morning group exercise schedule includes SilverSneakers® Classic, which will continued to be offered Mon-Fri at 10:00 am.
